

## **Toms decides to expand product recall**

Toms expands the product recall from November to include further products and “best before” dates. We have decided to expand the product recall to ensure that the consumers can have full confidence in the quality of our products. The recall in November was initiated after plastic was discovered in some of our marzipan bars, the plastic originated from broken lamellas in one of our machines.

CEO Carsten Thomsen would like to underline, that the expanded recall is initiated regardless of the fact, that Toms hasn't received any new customer complaints, regarding the other products that are covered by the extended recall:

“We take this action to eliminate any uncertainties, to ensure that our consumers continuously can have confidence in Toms, and trust the quality of our products”.

The expanded recall is quite extensive, and Toms regret the inconvenience conveyed for both customers and consumers:

“We regret the uncertainty and the inconvenience, caused by this extensive recall and we would like to apologize to both our customers and consumers. But the trustworthiness of Toms and the quality of our products is paramount” CEO Carsten Thomsen ends.

### **Background**

The case concerned previous findings of plastic in already recalled products. The plastic pieces varied in sizes of up to 3 cm and derived from defect plastic lamellas in a machine in Toms' production. The lamellas are made of plastic approved for food contact.

The products are sold to wholesalers and retailers in Denmark, Hungary, Finland, Estonia, Poland, UK, Belgium, Spain, Slovakia, Germany, Ireland, Sweden, Portugal, France, Holland, Norway, Iceland, Faroe Islands, Greenland, Malta, Switzerland, Turkey, Israel, Singapore, India, Lebanon, UAE, Qatar, Syria, Russia, Armenia and Belarus.
